Percy Owen Moore, 83, formerly of Altavista and Smith Mountain Lake died Sunday, February 5, 2017 at Heritage Green Assisted Living. He was the husband of Marie Yeatts Moore for sixty-one years.

He was born December 27, 1933 in Halifax County, a son of the late Douglas Branch Moore, Sr. and Elizabeth Shepherd Moore. He was a member of Rivermont Presbyterian Church and a former member of Altavista Presbyterian Church where he was extremely active. He was a retired supervisor with Centel and a veteran of the U.S. Navy. Percy was involved in his community as a member of the Altavista Lions Club; he volunteered at Bedford Ride and Habitat for Humanity; a former member of the Altavista Town Council and former member of the Board of Directors of the First National Bank of Altavista.

In addition to his wife, he is survived by a son, David Moore and his wife Terrie of Hurt; a daughter, Kathy Milam and her husband Kurt of Baltimore; a sister, Virginia Moore Yeaman of the Eastern Shore; two grandchildren, Kasha Marie Moore and David Lee Moore; and three great grandchildren, Madalyn Moore, David Moore, and Brayden Collier.

He was preceded in death by three brothers, Douglas B. Moore, Jr., William R. Moore, and Tarlton S. Moore.

A memorial service will be conducted at 11:00 a.m., Saturday, February 25, 2017 at Finch and Finch Chapel, Altavista by Pastor Ron Cox.
